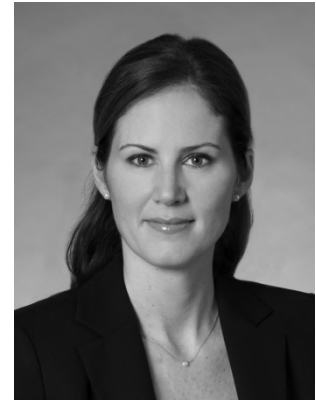

Financial terms of the agreement will not be disclosed.

It markets and sells its products through retail boutiques and department stores in the United States. The company was founded in 1995 and is based in Irvine, California. P.J. Salvage is



known for its luxury fabrics that are available in leading high-end department store chains and specialty boutiques.

Upon completion of the deal later this month, the acquired activities will operate as a part of Delta Galil USA. The Israeli firm plans to increase P.J. Salvage availability in upper end retailers in the US and globally. Founded in 1975, Delta Galil manufactures and markets branded and private label apparel products for men, women and children.
